BBC NEWS SCHOOL REPORT 2016-2017 PARENT/GUARDIAN CONSENT FORM

Dear Parent or Guardian,

Your son/daughter has been selected by their school to take part in BBC News School Report 2016-17. This is a project being run by the school with the support of the BBC. You can find out more about the project at www.bbc.co.uk/schoolreport

The purpose of this letter is to give you some information on the project and ask for your consent for your son/daughter to take part.

Background on BBC News School Report

BBC News School Report gives 11-16 year-olds in the UK the chance to make their own news reports. Teachers, with support from the BBC, help students develop their journalistic skills to tell stories that matter to them.

In March, schools take part in an annual News Day, simultaneously creating video, audio and text-based news reports, and publishing them on a school website, to which the BBC aims to link. The next News Day is **Thursday 16 March 2017**.

During the year the BBC may also contact the school to help them make more news stories. Your school may equally contact the BBC with story ideas from your son/daughter and the BBC may work with them to create this content. Neither the school, your son/daughter, nor the BBC is under any obligation to work on stories if either party feels unable to.

The BBC also intends to report on students activities in some schools. This is so people around the UK can see and hear about the news young people think is important and so other schools can find out about the project.

Social Media

Social media is a tool used by many journalists to gather news. Increasingly it is also used by the BBC to reach large audiences, for example by publishing content on the BBC Facebook and Twitter pages or BBC YouTube channels. This is particularly important as more and more people are not getting their news via radio or TV.

So when you agree to your son/daughter taking part you are agreeing that their work, or audio or audio-visual recordings and still images featuring them, may appear on the school web pages but possibly also on BBC radio, TV or online. It is also possible they could feature on the BBC School Report social media accounts and also on some of the BBC News accounts. However it is not an essential part of the project for young people to use social media themselves.

You can find advice about helping your son/daughter keep safe online and on social media websites via charities such as Childnet (<u>www.childnet.com/parents-and-carers</u>) and Family Online Safety Institute (<u>www.fosi.org/good-digital-parenting</u>) or <u>www.thinkuknow.co.uk</u> which is run by the Child Exploitation and Online Protection Centre (CEOP).

The minimum age for most social media accounts is 13+. We would recommend you advise your son/daughter to adhere to the recommendations and rules of social media sites regarding the minimum age of account holders.

Child Protection and Data Protection

The school will retain responsibility for your son/daughter's welfare while they participate in the project. They will ensure that students taking part in the project will be accompanied by a member of school staff at all times. The school has agreed to make sure that only students' first names are used to help protect their identity.

The BBC is committed to safeguarding the welfare of the children and young people it works with, and School Report is run according to the BBC's Child Protection Policy and Editorial Guidelines, which are designed to ensure that this happens. Terms of the your son/daughter's involvement

Your son/daughter will not be able to participate unless this form has been signed and returned to their school. The school will retain this permission form but the BBC has the right to ask for a copy of it at any time.

In some cases schools may work with other organisations on the project e.g. other local schools. Please contact your school directly if you want to know whether they will be working with partners in this way.
